Welcome, I would personally like to welcome you to the 45th Annual 2022 Doddridge County Fair which will be held August 16 – 20, 2022.

- Vendors must complete a Vendor Application, Liability Insurance Certificate, Payment will be on setup day return to the Doddridge County Fair Commission.
- This year we have partnered with Francis L Dean & Associates to provide a low cost for our vendors. Cost is \$50.00 for a \$1,000,000 occurrence / \$2,000,000 aggregate liability insurance policy that runs from Tuesday, August 16, 2022 through Sunday, August 21, 2022; you can purchase directly from Francis L. Dean on their website link posted on our Vendor Page.
- All commercial vendors must provide the Doddridge County Fair Commission with a certificate of liability insurance list the “Doddridge County Fair Commission, Inc. as additional insured.
- **Concessions Vendors** – The lineup of Concessions Vendors will be the same as 2021. We start setting up at 8 AM on Monday, August 15, 2022 suggest Food Vendors be there at that time or shortly after. How our event is setup need to work food booths in more of a first come / first serve basis if you aren’t able to be here please contact the Chairman to see if can mark off your space if that is possible.
- **All Vendors:** Lone Pine Campground at Doddridge County Park will be expanded into more RV slips available with water & electrical connections. All Vendors will need to park in the campground area instead of on the fairgrounds per the Park Commission.
- We will once again have an ATM on-site to help drive your business...
- The Doddridge County Park has upgraded the Wi-Fi at the Park so easier to take electronic payments for your business part of pool upgrade project.

This lease agreement, made this ____ day of ____, 2022 by and between the Doddridge County Fair Commission, Inc. (Lessor) and _____ (Lessee), for the total sum of \$_____ payable by lessee to lessor at the time of submitting the lease agreement, doe agree to abide by the following terms and conditions.

All leased space shall be for a term of five days beginning on August 16 and ending on August 20, 2022.

Lessee agrees that they are operating as an independent contractor and will identify themselves as such during all operations during the time of the lease.

Lessee shall submit with this application a copy of a valid insurance policy or certificate of insurance.

All applications must also include a photo of your booth.

Lessee shall not move onto assigned premises until the assigned setup time.

Lessee will have their booth open on all days of the Fair during the Fair's normal operating hours (T-F 4:00 pm – 11:00 pm and Sat 12 noon – 11:00 pm) Exceptions will be made for Single Day Booths.

No vehicle campers or trailers may be parked in or behind assigned booth spaces. Additional stock, parking, or camping is located elsewhere on the grounds.

Lessee shall bring no motor on the fairgrounds property during the lease except for the period each morning (T-F 8:00 am - 12:00 noon; Sat. 8:00 – 10:00 am) for the purpose of providing stock and materials to booth.

Absolutely No Operation of unapproved motorized vehicles will be allowed on park grounds during all operating hours. This includes all 4-wheelers, golf carts, etc.

Lessee may not change any items to be sold, activity to be offered or menu served from that listed on approved Vendor Application and may not solicit or conduct business outside the assigned booth area.

Lessee is responsible for providing all connections and supplies for connecting their booth into electric, water or other services.

Lessee is responsible for abiding by all copyright laws pertaining to all booth items during the lease.

Lessee shall keep the lease premises in a clean and sanitary condition at all times and properly dispose of all trash in designated area during the lease.

Lessee shall dispose of grease or oils used for cooking during the fair in assigned approved location or will need to take with them. If you do not abide by this policy you will not be invited back to future fairs.

Lessee shall comply with all State, Fair & local health and safety regulations.

Lessee, upon vacating the premises, shall completely clean the premises of all litter and dispose of the same in a designated area as directed by Lessor.

Lessee hereby releases Lessor and the Doddridge County Park from last claims demands, and damages what-so-ever in relation to personal injury and/or property damage sustained while operating their business on the leased premises.

Lessee acknowledges that if provisions of this agreement are not adhered to that they will forfeit the privilege of future patriation as a vendor at the Doddridge County Fair.

The Doddridge County Fair Commission reserves the right to change the terms of this lease at any time without prior notice.

NO Pets Allowed on Fairgrounds! Service animals specially trained to aid a person with a disability are welcome.

No refunds of any and all application fees.

There will be a \$35.00 charge for returned checks from the vendor's bank for nonpayment.
